2. Candidates are required to send scanned copy of application to **recovery@rmgb.in** (application, ID proof, age proof, experience etc.) failing which their candidature will not be considered for short listing/ interview.

3. Candidature will be subject to verification of all details/ documents with the original when a candidate reports for interview (if called).

4. In case a candidate is called for interview and is found not satisfying the eligibility criteria (Age and Experience etc.) he/ she will neither be allowed to appear for the interview.

D. Call Letter for Interview:

Interview: Intimation/call letter for interview, where required, will be sent by email or will be uploaded on Bank's website. NO HARD COPY WILL BE SENT.

E. Proof of Identity to be Submitted at the interview

The candidates must bring one photo identity proof such as Passport/Aadhar/ PAN Card/Driving License/Voter's Card/ Bank Passbook with duly attested photograph in original as well as a selfattested Photocopy thereof. Failing which or if identity of candidates is in doubt the candidate will not be permitted to appear for the interview.

F. Action Against Candidate Found Guilty of Misconduct:

Candidates are cautioned that they should not furnish any particulars that are false, tampered/fabricated and they should not suppress any material information while filling up the application form.

At the time interview, if a candidate is (or has been) found guilty of:

(i) impersonating or procuring impersonation by any person or (ii) misbehaving in the interview or (ii) resorting to any irregular or improper means in connection with his/her candidature for selection or (iii) obtaining support for his/her candidature by any unfair means, such a candidate may, in addition to rendering himself/ herself liable to criminal prosecution, will also be liable: a) to be disqualified from the selection process for which he/she is a candidate

b) to be debarred, either permanently or for a specified period, from any interview or engagement conducted by Bank.
